Session 1: Youth College Prep – Governor's Room

Florenso Hernandez – Senior Admissions Counselor, Michigan State University, Office of Admissions and President, ALSAME (Advocates for Latino Student Advancement in Michigan Education)

Liliana Salas – Director, Western Michigan University – CAMP (College Assistance Migrant Program)

This workshop will provide Latinx youth information to assist in their preparation for enrolling in Michigan colleges and universities. Mr. Hernandez will include a discussion of the role of ALSAME, *Advocates for Latino Student* and Ms. Salas will provide information about the college-bound preparation process. She will also inform workshop participants of noteworthy colleges and universities with programs that assist students of color.

Session 2: 2020 Census – Room 102

Marilyn A. Sanders – Census Regional Director / Chicago

The 2020 Census workshop will provide information on the US Census Bureau structure to be in place in October 2018 and will comment on anticipated obstacles facing Latinos in the U.S. that will prevent them from being counted. The Census Bureau hiring process will also be presented to enable attendees to share this information with members of their Latinx communities. Conference participants will have the opportunity to discuss fears facing Latinxs documented and undocumented immigrants and their hesitancy to fill out the census forms.

Session 3: Immigration 101 – Room 103

This workshop will provide a general overview of immigration law touching on topics such as how to become a resident, citizen, and discuss other forms of immigration status. Presenters will discuss the status of unaccompanied minors in the US, deportation proceedings, various public benefits, and provide federal and state policy updates. This workshop will also present information for those who may work with Latinos facing immigration issues and potential referral options.

Session 4: Gerrymandering – Room 104

Walt Sorg – Voters Not Politicians

This workshop will discuss the effects of gerrymandering. Discussed will include “the manipulation of borders and boundaries”, its potentially detrimental effects on people and communities of color, and how the points of concentration in districts can be diluted to the level of not having the voting power to influence elections. The other side of the discussion is how the Latinx community can become active and eliminate gerrymandering through the electoral process.

Keynote Speaker.....Jose Angel Gutierrez, PhD, JD

Jose Angel Gutierrez is a Crystal City, Texas native. He has degrees from University of Texas at Austin (Ph.D.), and University of Houston, Bates College of Law, Houston, Texas (J.D.). Gutierrez was a professor of Political Science at University of Texas-Arlington (UTA) until June 5, 2015 and designated Professor Emeritus on October 8, 2015. He was also the founder of the Center for Mexican American Studies at UTA. He has authored and co-authored 14 books; three of which are revised editions of a text on Texas politics. The most recent publication is *The Eagle Has Eyes: The FBI Surveillance of Cesar E. Chavez and the United Farm Workers Union of America, 1965-1975* (Michigan State University Press, pending release September 2018). Two other books are under contract, another in the

final stages of preparation. Dr. Gutierrez was a Chicano activist, community organizer, and educational reformer during the Chicano Movement. He co-founded the Mexican American Youth Organization (MAYO) and the Raza Unida Party of Texas. He was a key figure in the founding of the Mexican American Unity Council, The National Council of La Raza, the Mexican American Legal Defense and Educational Fund and The Midwest and Northwest Voter Registration and Education Projects. Dr. Gutierrez is featured, cited, and quoted in several encyclopedias, books, and various documentaries for his activism and contributions during the Chicano Movement era. Gutierrez is the recent recipient of the 20th International Latino Book Award for Best Biography in the Non-fiction Section for his book about San Antonio Chicano activist Judge Alberto A. Peña. It is published by the Michigan State University Press (JSRI Latinos in the United States Series.)
